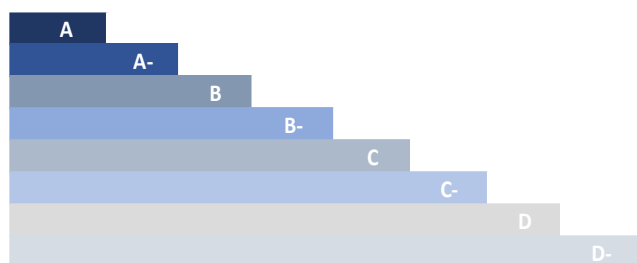
OVERVIEW

- **WATER ACCOUNTING:** *100% of sites, facilities and operations for each applicable water aspect are monitored and how the figures have changed is tracked over the years. There is an understanding that your water dependence may change in the future.*
- **RISK ASSESSMENT:** *Next steps - ensure to carry out a robust and comprehensive water risk assessment at relevant stages of the value chain, by combining multiple tools and methods and by including relevant stakeholders and contextual issues.*
- **TARGETS AND GOALS:** *Next steps - set ambitious mid- and long-term water targets and goals, and demonstrate significant progress against them.*
- **GOVERNANCE:** *Water-related issues are in the agenda of at least some meetings and they are integrated to the organizational strategy and business plans, capital expenditures, risk management policies, or acquisitions and divestiture.*
- **WATER POLICIES:** *Next steps - have a company-wide public water policy that comprises company water targets and goals, commitment with public policy initiatives, such as the SDGs, reference to international standards and widely-recognized water initiatives, commitment to water stewardship and/or collective action.*
- **VALUE CHAIN ENGAGEMENT:** *Next steps - carry out value chain engagement on water-related issues or have an intention to engage.*

- *Explore water valuation options, e.g. setting an internal price for water;*
